

Ohio Bureau of Workers' Compensation Vocational Rehabilitation Fee Schedule

BWC creates local billing codes for the delivery of vocational rehabilitation services. Definitions for these codes are specific to Ohio BWC and contain a brief description of the service. Policy supporting the use of these service codes is outlined in the MCO Policy Reference Guide.

All service codes are paid per the identified fee for that code. Vocational rehabilitation case management interns will receive 85% of the fee.

By Report (BR) - These are service codes that have no established fees for the identified service. The MCO is to be provided with a detailed report of the service and will determine the appropriate rate of reimbursement and follow standard bill reimbursement protocols for payment of vocational rehabilitation services.
